1. Who we are

2. Scope of this Policy

This Policy explains how we collect, use, share and protect personal data obtained through the Website and our official social-media pages (collectively, the "Site"). It does not cover third-party websites that may be linked from our Site; please review their privacy notices separately.

3. Personal data we collect

4. Why we process your data

We process personal data for the following purposes:

1. Providing and operating the Site (enabling access, answering enquiries).

- 2. **Site security and maintenance**, including fraud prevention and protection of our IT, physical and network infrastructure.
- 3. **Analytics** to understand how visitors use the Site and to improve usability.
- 4. **Marketing and advertising** showing you targeted ads or sending marketing communications we believe may interest you, based on your interactions with the Site.

5. Legal bases for processing

6. Sharing your personal data

We share data only when necessary and in line with this Policy:

- Within InnoMaker relevant departments (e.g., IT for browsing data, Sales for your enquiry, Legal, Finance, Internal Audit) receive access strictly on a need-to-know basis.
- Service providers (processors) e.g., cloud hosting and technical-support vendors that store or process data on our behalf under written instructions.
- Other recipients law-enforcement, regulatory or judicial authorities, legal advisers, external consultants, business partners, and entities involved in a merger or acquisition, where required or permitted by law.
- **Analytics partner** We act as joint controller with **Google Ireland Limited** under the Google Measurement Controller-to-Controller Data Protection Terms for analytics services.

We do **not** sell or otherwise disclose your data for advertising or marketing without your consent.

7. International transfers

Some recipients are located outside the European Economic Area (EEA), including in the United States. Where we transfer data internationally, we rely on:

- EU Standard Contractual Clauses (SCCs);
- The recipient's Binding Corporate Rules; or
- An adequacy decision confirming an equivalent level of protection.

8. Cookies and similar technologies

We use cookies to make the Site work, analyse traffic and, with your consent, personalise marketing. You can manage or withdraw consent at any time via the cookie banner or your browser settings. Disabling cookies may affect Site functionality. Session cookies are deleted when you close your browser; persistent cookies remain for the period specified in our cookie settings.

Social-media plugins

Our Site integrates Facebook and LinkedIn plugins. When you load a page containing such a plugin, your browser establishes a direct connection to the respective provider. These providers may collect data (including your IP address and page visits) regardless of whether you have an account with them. We act as joint controller with these platforms when they collect data during your visit. More information:

9. Data retention

We retain personal data:

- General rule for 2 years after our last interaction or business relationship with you.
- Contracts, communications and business correspondence for 5 years (or longer if accounting/tax laws require up to 8 years).
- Legal claims for the limitation period required to establish, exercise or defend legal rights.

Once retention periods expire, we delete or anonymise data unless further processing is required by law.

10. Security

We employ industry-standard safeguards (firewalls, intrusion-detection systems, access-controls, procedures) to protect data against loss, alteration or unauthorised access. If you believe your data or our Site is insecure, please contact **info@innomakerpartners.com** immediately.

11. Confidentiality

All personal data are handled in strict confidence.

12. Your rights

Subject to applicable law (notably the EU GDPR), you may:

- Withdraw consent at any time without affecting prior processing.
- Access your personal data.

- **Erase** data ("right to be forgotten").
- **Restrict** processing.
- **Data portability** receive data in a structured, machine-readable format and transmit it to another controller.
- **Object** to processing based on legitimate interests, including profiling and direct marketing.
